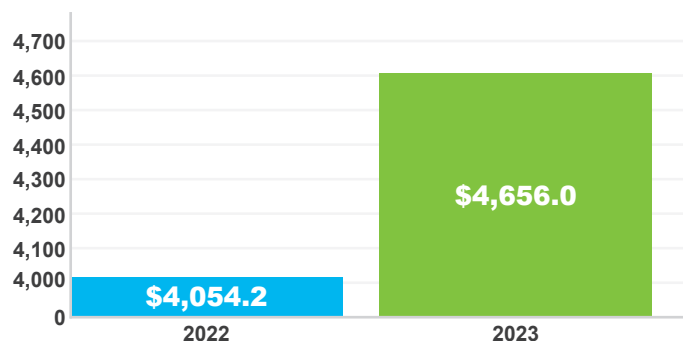
Sagicor raised more than \$450 million of net new capital and acquired a listing on the Toronto Stock Exchange in 2019, providing the Company with international exposure and greater access to capital to fund growth. **Sagicor Financial Company Ltd. is listed on the Toronto Stock Exchange: ticker symbol SFC.**

2023 was another monumental year for Sagicor with the acquisition of ivari (Sagicor Canada), a leading individual life insurer in Canada focused on Universal Life and Term insurance in the middle-market. The expansion of the North American business (Sagicor USA and Sagicor Canada) was a significant driver of profitability to the organization in 2023, with Canada and the U.S. now representing 73% of Sagicor’s total assets. An additional result of the acquisition was recognition by S&P® Global Ratings (“S&P”), Morningstar DBRS (“DBRS”), AM Best, and Fitch Ratings (“Fitch”) for the enhancement to Sagicor Financial Company Ltds credit profile, diversification and capitalization.

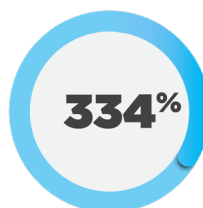

(RBC) Ratio

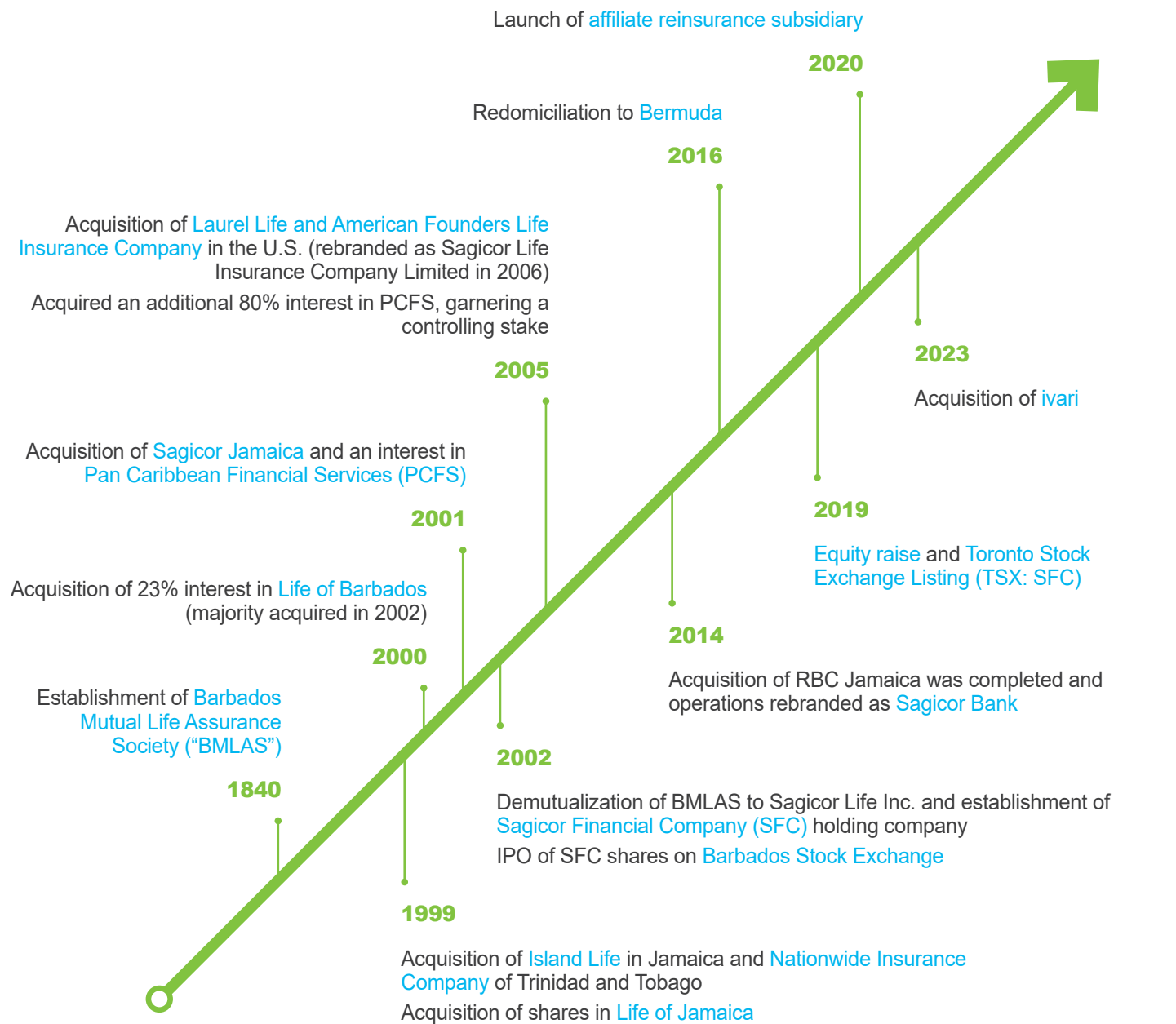

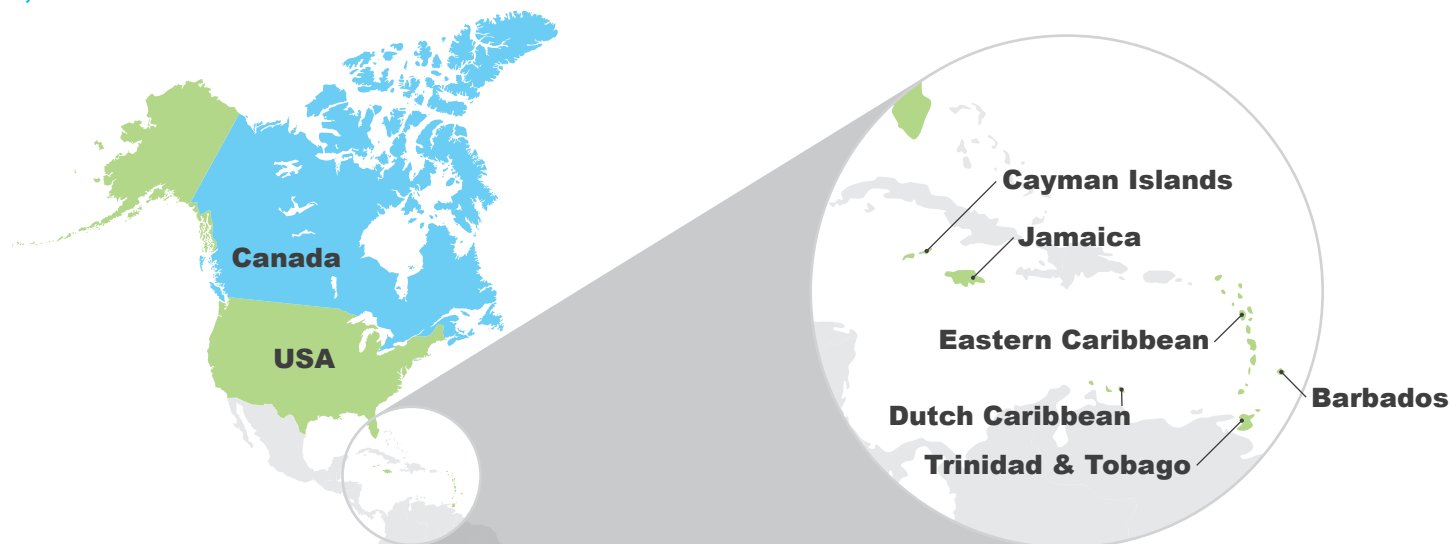


Sagicor (SFC) Total assets evolution⁴
